#### MLP MAKING A DIFFERENCE

Mrs. Joseph's living conditions were making her sick. An older adult with asthma, whose husband had recently passed away, Mrs. Joseph was living with friends in a private apartment that had both mold and a terrible mouse infestation, as well as suspected gas leakages. As a result of these poor conditions and their impacts on her asthma, Mrs. Joseph had been hospitalized multiple times. Her primary care physician was very concerned and contacted MLP | Boston. We supported Mrs. Joseph in getting a Breathe Easy at Home inspection of the unit's condition, as well as securing medically-based priority status for a public housing unit of her own. Mrs. Joseph is now living in an apartment free of asthma triggers, and has had no recent hospitalizations.

# A TIMELY TIP FOR CLINICAL PARTNERS





Modestly increased state funding to support homeless families living in shelter motels is on the horizon. These funds will augment HomeBASE funding (up to \$4,000) by providing up to an additional \$2,000, meaning eligible families will have up to \$6,000 total to pursue alternatives to living in motel shelter.

Also, if a family's \$6,000 runs out and its effort to find/stabilize affordable housing does not bear fruit despite following the program rules, the family can get into shelter once 3 months have passed since its receipt of augmented HomeBASE funds (and provided the family still meets other EA shelter eligibility requirements). This is a positive change to a prior regulation that usually barred families from shelter for 12 months if they accepted even less funds through HomeBASE. We hope this policy improvement benefits many families that were otherwise at even higher risk of abject homelessness during these cold winter months.

# **PROJECT UPDATES**

- Aging Right in the Community: MLP | Boston and the Elders Living at Home Program (ELAHP) at BMC have been establishing themselves as a working team on behalf of low-income, medically vulnerable older adults confronting housing instability. Early in 2014, we will outreach to community partners to welcome additional referrals of at-risk elders. According to ELAHP Program Director Eileen O'Brien, "[j]ust in these first few months of partnering, it's clear that our housing case management efforts are really strengthened by the MLP connection. MLP flags legal risks to clients that often aren't obvious, and identifies potential solutions."
- Vital Village Network Awarded Implementation Grant: Renee Boynton-Jarrett, MD, ScD, shared exciting news with the Vital Village Network, in which MLP | Boston has participated as a design team member and innovation grantee throughout the past planning grant year: "We are very humbled and pleased to announce that our collective efforts have resulted in an implementation grant from the Doris Duke Charitable Foundation. # 4TH ANNUAL MA MLP CONFERENCE

On October 28<sup>th</sup>, MLP | Boston hosted the fourth annual Massachusetts Medical-Legal Partnership conference, which drew 125 interdisciplinary stakeholders not only from New England, but also from as far away as Arkansas and Saskatchewan. Former MA Department of Public Health Commissioner John Auerbach spoke about the progress that's been made in reducing health disparities in Massachusetts, as well as many challenges that remain on the path to full health equity for vulnerable populations in this state and beyond. A plenary panel of



health care providers, administrators, and researchers spoke frankly about the systems that need to more fully align before social determinants of health can be addressed effectively and efficiently. Conference participants then proceeded to engage in 12 separate workshops on subjects ranging from MLP best practices in trauma-informed advocacy, to current research on the impact of legal care on patients' treatment adherence to cancer patients' rights, to reasonable accommodation from their employers so they can get healthy and remain stably employed. According to one participant, the conference involved "[e]xcellent topics, presenters, and handouts. I wish I could have attended every session."
